

Riesz Basis Property of the Generalized Eigenvector System of A Timoshenko Beam ¹

Abstract. The Riesz basis property of the generalized eigenvector system of a Timoshenko beam with boundary feedback controls applied to two ends is studied in the present paper. The spectral property of the operator \mathcal{A} determined by the closed loop system is investigated. It is shown that operator \mathcal{A} has compact resolvent and generates a C_0 semigroup, and its spectrum consists of two branches and has two asymptotes under some conditions. Furthermore it is proved that the sequence of all generalized eigenvectors of the system principal operator forms a Riesz basis for the state Hilbert space.

Keywords. Timoshenko beam, boundary feedback, generalized eigenvector system, Riesz basis.

1 Introduction

It is well known that many flexible structure systems, such as robotic system, can be described by Timoshenko beam equation with appropriate boundary conditions (see Timoshenko,1954; Morgül, 1991). In the past decades, there exists an extensive mathematical and engineering literature on the Timoshenko beam model, and varied controllers for the system have been designed to realize the stabilization of the system. Among them, the so-called boundary controller is more easy to realize. Therefore the boundary control problem of Timoshenko

beam system attracts much more attentions, and obtained a lot of important results, e.g., see Kim & Renardy, 1987; Morgül,1991,1992; Feng et al.,1995, 1998; Shi et al, 1998; Geist & McLaughlin, 2001; Pazoto& Menzala, 2000. It is proved that if only one control force or moment is applied to one end, then the system can be asymptotically but not uniformly stabilized. If both control force and moment are applied to the one end or two ends of the system respectively, then the controlled system can be uniformly stabilized. However, these results do not give any information about the decay rate and expression of solution of the controlled system. In practice, we often need to make some quantitative analysis for the controlled system. If a system has the Riesz basis property, i.e., the sequence of all generalized eigenvectors of the principal operator for the system forms a Riesz basis of the state Hilbert space, then any solution of the system can be expressed in terms of the Riesz basis, and the system satisfies the spectrum determined growth assumption, and hence the stability is determined by the spectrum of the system principal operator.

In the past several years, on the generation problem of Riesz basis of the generalized eigenvector system of flexible structure with boundary control, many authors have made a great effort, e.g. see Balakrishnan, 1998; Shubov, 1999, 2002; Xu & Feng, 2002; and the references therein. In Shubov 1999, the author proved the completeness of the generalized eigenvector sequence of the Timoshenko beam with some boundary feedback control. In the present paper, we give a counterexample to show that when the feedback gain is equal to the wave speed in this case, the sequence of the corresponding generalized eigenvectors is not complete.

In this paper we will consider the following homogeneous Timoshenko beam with boundary control:

$$\begin{cases} \rho \ddot{w}(x, t) - K(w''(x, t) - \varphi'(x, t)) = 0, & 0 < x < \ell, \\ I_\rho \ddot{\varphi}(x, t) - EI\varphi''(x, t) - K(w'(x, t) - \varphi(x, t)) = 0, & 0 < x < \ell, \\ w(0, t) = 0, \quad \varphi(0, t) = \theta(t), \\ w'(\ell, t) - \varphi(\ell, t) = u(t), \quad \varphi'(\ell, t) = 0, \end{cases} \quad (1.1)$$

where $\theta(t)$ and $u(t)$ are control functions. The aim is to design feedback controllers such that the energy of the closed loop system is asymptotically stable. Here we adopt the following feedback control law:

$$\dot{\theta}(t) = r(\varphi'(0, t) - \theta(t)) \quad \text{and} \quad u(t) = -\beta \dot{w}(\ell, t), \quad r > 0, \quad \beta > 0. \quad (1.2)$$

To prove the stability of the closed loop system, the idea is to show that the sequence of the generalized eigenvectors of the closed loop system forms a Riesz basis in the energy space. For this purpose, we use Bari's Theorem (see, Young,1980). Here the key step in the use of Bari' Theorem is to find a reference

basis of the state Hilbert space. We first introduce an auxiliary operator and prove that the sequence of the generalized eigenvectors of this auxiliary operator forms a Riesz basis. Then in terms of Bari's Theorem, we prove that the sequence of the generalized eigenvectors of the closed loop Timoshenko system forms a Riesz basis in Hilbert state space. Although the system we consider is with constant coefficients, but it is not difficult to extend to variable coefficient Timoshenko case.

The remaining part of the paper is arranged as follows. In the next section, we give a basic spectral analysis of \mathcal{A} determined by the closed loop system (1.1) and (1.2), and describe the distribution of eigenvalues of \mathcal{A} . In section 3, we introduce an auxiliary operator \mathcal{A}_0 which, in fact, is the principal part of \mathcal{A} , and prove that \mathcal{A}_0 has the Riesz basis property. Finally, in section 4, by the asymptotic analysis of the operator \mathcal{A} , using Bari's Theorem, we prove \mathcal{A} has the Riesz basis property, i.e., the generalized eigenvectors of the operator \mathcal{A} forms a Riesz basis for the state Hilbert space.

2 Spectral analysis of system operator

In this section we set up the Hilbert state space, and write the closed loop system (1.1) and (1.2) into an evolutionary equation in the state Hilbert space. Further, we discuss the spectral property of the operator determined by the closed loop system.

Let us consider the following Timoshenko beam with boundary feedback control:

$$\begin{cases} \rho \ddot{w}(x, t) - K(w''(x, t) - \varphi'(x, t)) = 0, & 0 < x < \ell, \\ I_\rho \ddot{\varphi}(x, t) - EI\varphi''(x, t) - K(w'(x, t) - \varphi(x, t)) = 0, & 0 < x < \ell, \\ w(0, t) = 0, \quad \varphi(0, t) = \theta(t), \quad \varphi'(\ell, t) = 0, \\ w'(\ell, t) - \varphi(\ell, t) = -\beta \dot{w}(\ell, t), \quad \beta > 0, \\ \dot{\theta}(t) = r(\varphi'(0, t) - \theta(t)), \quad r > 0 \end{cases} \quad (2.1)$$

Define the state space

$$\mathcal{H} = V_0^1 \times L_\rho^2(0, \ell) \times H^1(0, \ell) \times L_{I_\rho}^2(0, \ell),$$

where $V_0^k = \{\varphi \in H^k(0, \ell) \mid \varphi(0) = 0\}$, $k = 1, 2$, and $H^k(0, \ell)$ is the usual Sobolev space of order k . For $Y_1 = [w_1, z_1, \varphi_1, \psi_1]^T, Y_2 = [w_2, z_2, \varphi_2, \psi_2]^T \in \mathcal{H}$, where and after the superscript T denotes the transpose of matrix or vector, the inner product in \mathcal{H} is defined by

$$\begin{aligned} \langle Y_1, Y_2 \rangle &= \int_0^\ell K w_1' \overline{w_2'} dx + \int_0^\ell \rho z_1 \overline{z_2} dx + \int_0^\ell EI \varphi_1' \overline{\varphi_2'} dx \\ &\quad + \int_0^\ell I_\rho \psi_1 \overline{\psi_2} dx + EI \varphi_1(0) \overline{\varphi_2(0)}. \end{aligned}$$

Define operator \mathcal{A} in \mathcal{H} :

$$\mathcal{A} \begin{pmatrix} w \\ z \\ \varphi \\ \psi \end{pmatrix} = \begin{pmatrix} z \\ \frac{K}{\rho}(w'' - \varphi') \\ \psi \\ \frac{EI}{I_\rho}\varphi'' + \frac{K}{I_\rho}(w' - \varphi) \end{pmatrix}, \quad (2.2)$$

$$\mathcal{D}(\mathcal{A}) = \left\{ [w, z, \varphi, \psi]^\top \in \mathcal{H} \mid w \in V_0^2, z \in V_0^1, \varphi \in H^2(0, \ell), \psi \in H^1(0, \ell) \right. \\ \left. \psi(0) = r(\varphi'(0) - \varphi(0)), w'(\ell) - \varphi(\ell) = -\beta z(\ell), \varphi'(\ell) = 0 \right\}.$$

Then the closed loop system (2.1) can be written as an evolutionary equation in \mathcal{H} :

$$\frac{d}{dt}Y(t) = \mathcal{A}Y(t), \quad \forall t > 0, \quad (2.3)$$

where $Y(t) = [w(\cdot, t), \dot{w}(\cdot, t), \varphi(\cdot, t), \dot{\varphi}(\cdot, t)]^\top$.

Theorem 2.1 Let \mathcal{A} be defined as above. Then \mathcal{A} has compact resolvent and generates a C_0 semigroup.

Proof The proof is direct and is omitted.

Now we are in a position to investigate the eigenvalue problem of \mathcal{A} . For $\lambda \in \mathbb{C}$, we solve eigenvalue-equation

$$(\lambda I - \mathcal{A})Y = 0, \quad Y = [w, z, \varphi, \psi]^\top.$$

This implies that $z(x) = \lambda w(x)$, $\psi(x) = \lambda \varphi(x)$ and the function pair $(w(x), \varphi(x))$ satisfies the equations

$$\begin{cases} \rho \lambda^2 w(x) - K(w''(x) - \varphi'(x)) = 0, & 0 < x < \ell, \\ I_\rho \lambda^2 \varphi(x) - EI \varphi''(x) - K(w'(x) - \varphi(x)) = 0, & 0 < x < \ell, \end{cases} \quad (2.4)$$

with the boundary conditions

$$\begin{cases} w(0) = 0, & \lambda \varphi(0) = r(\varphi'(0) - \varphi(0)), \\ w'(\ell) - \varphi(\ell) = -\beta \lambda \varphi(\ell), & \varphi'(\ell) = 0. \end{cases} \quad (2.5)$$

For the sake of simplicity, for a fixed $\lambda \in \mathbb{C}$, set

$$\rho_1^2 = \frac{\rho}{K}, \quad \rho_2^2 = \frac{I_\rho}{EI}, \quad a = \rho_1^2 \lambda^2, \quad b = \rho_2^2 \lambda^2 + \frac{K}{EI}, \quad c = -\frac{K}{EI}. \quad (2.6)$$

Denote by μ_1 and μ_2 the two roots of the quadratic equation

$$\mu^2 - (a + b + c)\mu + ab = 0, \quad (2.7)$$

i.e.,

$$\mu_1 = \mu_1(\lambda) = \frac{(a + b + c) + \sqrt{(a + b + c)^2 - 4ab}}{2},$$

$$\mu_2 = \mu_2(\lambda) = \frac{(a+b+c) - \sqrt{(a+b+c)^2 - 4ab}}{2}.$$

Assume that $\mu_1 \neq \mu_2$, and define functions $w_j(\lambda, x), \varphi_j(\lambda, x)$ for $j = 2, 3, 4$ as follows:

$$\left\{ \begin{array}{l} w_2(\lambda, x) = \frac{b}{\mu_1 - \mu_2} \left(\frac{\sinh \sqrt{\mu_1} x}{\sqrt{\mu_1}} - \frac{\sinh \sqrt{\mu_2} x}{\sqrt{\mu_2}} \right), \\ w_3(\lambda, x) = \frac{1}{\mu_1 - \mu_2} \left((\mu_1 - b) \frac{\sinh \sqrt{\mu_1} x}{\sqrt{\mu_1}} - (\mu_2 - b) \frac{\sinh \sqrt{\mu_2} x}{\sqrt{\mu_2}} \right) \\ w_4(\lambda, x) = \frac{1}{\mu_1 - \mu_2} (\cosh \sqrt{\mu_1} x - \cosh \sqrt{\mu_2} x), \\ \varphi_2(\lambda, x) = \frac{1}{\mu_1 - \mu_2} (-(\mu_2 - b) \cosh \sqrt{\mu_1} x + (\mu_1 - b) \cosh \sqrt{\mu_2} x), \\ \varphi_3(\lambda, x) = \frac{c}{\mu_1 - \mu_2} (\cosh \sqrt{\mu_1} x - \cosh \sqrt{\mu_2} x), \\ \varphi_4(\lambda, x) = \frac{1}{\mu_1 - \mu_2} \left((\mu_1 - a) \frac{\sinh \sqrt{\mu_1} x}{\sqrt{\mu_1}} - (\mu_2 - a) \frac{\sinh \sqrt{\mu_2} x}{\sqrt{\mu_2}} \right). \end{array} \right. \quad (2.8)$$

Then the general solution of (2.4) can be written as

$$w(x) = C_2 w_2(\lambda, x) + C_3 w_3(\lambda, x) + C_4 w_4(\lambda, x), \quad (2.9)$$

$$\varphi(x) = C_2 \varphi_2(\lambda, x) + C_3 \varphi_3(\lambda, x) + C_4 \varphi_4(\lambda, x), \quad (2.10)$$

where C_2, C_3, C_4 are any constants to be determined. In order for $(w(x), \varphi(x))$ meet the boundary conditions (2.5), the constants C_2, C_3, C_4 must satisfy

$$\begin{aligned} C_4 &= \frac{\lambda + r}{r} C_2, \\ C_2 a_{11}(\lambda) + C_3 a_{12}(\lambda) &= 0, \\ C_2 a_{21}(\lambda) + C_3 a_{22}(\lambda) &= 0, \end{aligned}$$

where

$$\begin{aligned} a_{11}(\lambda) &= w_2'(\lambda, \ell) - \varphi_2(\lambda, \ell) + \lambda \beta w_2(\lambda, \ell) \\ &\quad + \frac{\lambda + r}{r} [w_4'(\lambda, \ell) - \varphi_4(\lambda, \ell) + \lambda \beta w_4(\lambda, \ell)], \\ a_{12}(\lambda) &= w_3'(\lambda, \ell) - \varphi_3(\lambda, \ell) + \lambda \beta w_3(\lambda, \ell), \\ a_{21}(\lambda) &= \varphi_2'(\lambda, \ell) + \frac{\lambda + r}{r} \varphi_4'(\lambda, \ell), \\ a_{22}(\lambda) &= \varphi_3'(\lambda, \ell). \end{aligned}$$

Set

$$\Gamma(\lambda) = \det \begin{pmatrix} a_{11}(\lambda) & a_{12}(\lambda) \\ a_{21}(\lambda) & a_{22}(\lambda) \end{pmatrix}, \quad (2.11)$$

Theorem 2.2. Let $w_j(\lambda, x), \varphi_j(\lambda, x)$ for $j = 2, 3, 4$ and $\Gamma(\lambda)$ be defined as before. Then

1) the spectrum $\sigma(\mathcal{A})$ of \mathcal{A} consists of all eigenvalues of \mathcal{A} , and $\lambda \in \sigma(\mathcal{A})$ if and only if $\Gamma(\lambda) = 0$;

2) let $\lambda \in \sigma(\mathcal{A})$, then the corresponding eigenvector can be chosen as

$$\Phi_\lambda = C_2 \begin{pmatrix} \frac{1}{\lambda} \left[w_2(\lambda, x) + \frac{\lambda+r}{r} w_4(\lambda, x) \right] \\ w_2(\lambda, x) + \frac{\lambda+r}{r} w_4(\lambda, x) \\ \frac{1}{\lambda} \left[\varphi_2(\lambda, x) + \frac{\lambda+r}{r} \varphi_4(\lambda, x) \right] \\ \varphi_2(\lambda, x) + \frac{\lambda+r}{r} \varphi_4(\lambda, x) \end{pmatrix} + C_3 \begin{pmatrix} \frac{1}{\lambda} w_3(\lambda, x) \\ w_3(\lambda, x) \\ \frac{1}{\lambda} \varphi_3(\lambda, x) \\ \varphi_3(\lambda, x) \end{pmatrix}, \quad (2.12)$$

where (C_2, C_3) is some nonzero solution of following linear equations

$$\begin{cases} C_2 a_{11}(\lambda) + C_3 a_{12}(\lambda) = 0, \\ C_2 a_{21}(\lambda) + C_3 a_{22}(\lambda) = 0. \end{cases} \quad (2.13)$$

Furthermore, for each $\lambda \in \sigma(\mathcal{A})$, the eigen-subspace of \mathcal{A} associated with λ is of dimension one.

3) If $\beta \neq \rho_1$ and $r\rho_2 \neq 1$, then the spectrum $\sigma(\mathcal{A})$ of \mathcal{A} has two asymptotes. More precisely, there is a positive integer N such that for each n with $|n| \geq N$, two eigenvalues $\lambda_n^{(1)}$ and $\lambda_n^{(2)}$ of \mathcal{A} are both simple and has the following asymptotic expression:

$$\lambda_n^{(1)} = \begin{cases} \frac{1}{2\rho_1 \ell} \ln \left| \frac{\beta - \rho_1}{\beta + \rho_1} \right| + \frac{n\pi i}{\rho_1 \ell} + O\left(\frac{1}{n}\right), & \text{if } \beta - \rho_1 > 0, \\ \frac{1}{2\rho_1 \ell} \ln \left| \frac{\beta - \rho_1}{\beta + \rho_1} \right| + \frac{(2n+1)\pi i}{2\rho_1 \ell} + O\left(\frac{1}{n}\right), & \text{if } \beta - \rho_1 < 0, \end{cases} \quad (2.14)$$

and

$$\lambda_n^{(2)} = \begin{cases} \frac{1}{2\rho_2 \ell} \ln \left| \frac{r\rho_2 - 1}{r\rho_2 + 1} \right| + \frac{n\pi i}{\rho_2 \ell} + O\left(\frac{1}{n}\right), & \text{if } r\rho_2 - 1 > 0, \\ \frac{1}{2\rho_2 \ell} \ln \left| \frac{r\rho_2 - 1}{r\rho_2 + 1} \right| + \frac{(2n+1)\pi i}{2\rho_2 \ell} + O\left(\frac{1}{n}\right), & \text{if } r\rho_2 - 1 < 0. \end{cases} \quad (2.15).$$

Proof The assertions 1) and 2) are immediate. Here we only prove the assertion 3).

Obviously, $\Gamma(\lambda)$ is an entire function in $\lambda \in \mathbb{C}$. By using (2.7) and (2.8), a lengthy calculation shows that

$$\lim_{\operatorname{Re} \lambda \rightarrow \infty} \frac{4\Gamma(\lambda)}{\lambda} = \left[\rho_2 + \frac{1}{r} \right] \left[1 + \frac{\beta}{\rho_1} \right]$$

and

$$\lim_{\operatorname{Re} \lambda \rightarrow -\infty} \frac{4\Gamma(\lambda)}{\lambda} = \left[\rho_2 - \frac{1}{r} \right] \left[1 - \frac{\beta}{\rho_1} \right], \quad \text{if } \rho_1 \neq \beta, \quad r\rho_2 \neq 1, \quad (2.16)$$

$$\lim_{\operatorname{Re} \lambda \rightarrow -\infty} 4\Gamma(\lambda) = -1, \quad \text{if } \rho_1 = \beta, \quad r\rho_2 = 1, \quad (2.17)$$

Then there is a $M > 0$ large enough such that all zeros of $\Gamma(\lambda)$ lie in the strip $P_M = \{\lambda \in \mathbb{C} \mid -M \leq \operatorname{Re} \lambda \leq 0\}$. Note that the functions $\sinh \sqrt{\mu_j} \ell$ and

$\cosh \sqrt{\mu_j} \ell$ are bounded in $\lambda \in P_M$. Hence for $\lambda \in P_M$ with $|\lambda|$ large enough, we have

$$\frac{\Gamma(\lambda)}{\lambda} = \left[\cosh \rho_1 \lambda \ell + \frac{\beta}{\rho_1} \sinh \rho_1 \lambda \ell \right] \left[\rho_2 \sinh \rho_2 \lambda \ell + \frac{1}{r} \cosh \rho_2 \lambda \ell \right] + O(\lambda^{-1}) \quad (2.18)$$

Set

$$G(\lambda) = \left[\cosh \rho_1 \lambda \ell + \frac{\beta}{\rho_1} \sinh \rho_1 \lambda \ell \right] \left[\rho_2 \sinh \rho_2 \lambda \ell + \frac{1}{r} \cosh \rho_2 \lambda \ell \right]. \quad (2.19)$$

The zeros of $G(\lambda)$ are

$$\xi_n = \begin{cases} \frac{1}{2\rho_1 \ell} \ln \left| \frac{\beta - \rho_1}{\beta + \rho_1} \right| + \frac{n\pi i}{\rho_1 \ell}, & \text{if } \beta - \rho_1 > 0, \\ \frac{1}{2\rho_1 \ell} \ln \left| \frac{\beta - \rho_1}{\beta + \rho_1} \right| + \frac{(2n+1)\pi i}{2\rho_1 \ell}, & \text{if } \beta - \rho_1 < 0, \end{cases} \quad (2.20)$$

and

$$\eta_n = \begin{cases} \frac{1}{2\rho_2 \ell} \ln \left| \frac{r\rho_2 - 1}{r\rho_2 + 1} \right| + \frac{n\pi i}{\rho_2 \ell}, & \text{if } r\rho_2 - 1 > 0, \\ \frac{1}{2\rho_2 \ell} \ln \left| \frac{r\rho_2 - 1}{r\rho_2 + 1} \right| + \frac{(2n+1)\pi i}{2\rho_2 \ell}, & \text{if } r\rho_2 - 1 < 0. \end{cases} \quad (2.21)$$

Applying Rouché Theorem to (2.18), we can arrive that there is an integer N such that for each n with $|n| > N$, there exists only one zero $\lambda_n^{(1)}$ of $\Gamma(\lambda)$ in a small neighborhood of ξ_n , and similarly, there exists only one zero $\lambda_n^{(2)}$ of $\Gamma(\lambda)$ in a small neighborhood of η_n . Furthermore we have estimates

$$\lambda_n^{(1)} = \xi_n + O(\xi_n^{-1}) \quad \text{and} \quad \lambda_n^{(2)} = \eta_n + O(\eta_n^{-1}).$$

By the first assertion we know that $\lambda_n^{(1)}, \lambda_n^{(2)} \in \sigma(\mathcal{A})$. Note that all the zeros of $G(\lambda)$ are simple. So for n large enough, $\lambda_n^{(1)}, \lambda_n^{(2)} \in \sigma(\mathcal{A})$ are simple eigenvalues of \mathcal{A} . The proof is then complete. \square

Remark 2.3 If $1 \neq r\rho_2$ and $\beta \neq \rho_1$, then the spectrum of \mathcal{A} distributes in a strip parallel to the imaginary axis, and has two asymptotes in general. But if $\left| \frac{r\rho_2 - 1}{r\rho_2 + 1} \right| = \left| \frac{\rho_1 - \beta}{\rho_1 + \beta} \right|$, then these two asymptotes degenerate the same one. In this case we cannot say that each eigenvalue of \mathcal{A} with large modulus is simple or not.

When $1 = r\rho_2$ and $\beta = \rho_1$, the function $G(\lambda)$ has no zero. It follows from (2.17) that $\Gamma(\lambda)$ has only finitely many zeros. Therefore in this case the system of the generalized eigenfunctions of \mathcal{A} is not complete in the state space \mathcal{H} . This gives a counterexample of completeness result in Shubov (Shubov, 1999, 2002).

Theorem 2.4 There is no eigenvalue of \mathcal{A} on the imaginary axis.

Proof Firstly a direct computation shows that $0 \in \rho(\mathcal{A})$.

We now suppose that the assertion is not true. Then there is at least one $\lambda = i\tau \neq 0$ with $\tau \in \mathbb{R}$ such that $\lambda \in \sigma(\mathcal{A})$. Let $Y = (w, \lambda w, \varphi, \lambda \varphi)$ is a corresponding eigenvector of \mathcal{A} . We have

$$\operatorname{Re} \langle \mathcal{A}Y, Y \rangle = 0 = -K\beta |\lambda w(\ell)|^2 - EIr |\varphi'(0) - \varphi(0)|^2,$$

which implies that $w(\ell) = 0$ and $\varphi(0) = \varphi'(\ell)$. Since that λ is an eigenvalue of \mathcal{A} , we have $\varphi'(\ell) = \frac{\lambda + r}{r}\varphi(0)$, which holds only if $\varphi'(\ell) = \varphi(0) = 0$ because of $\lambda \neq 0$. So we have

$$w(x) = Cw_3(\lambda, x), \quad \varphi(x) = C\varphi_3(\lambda, x),$$

where C is a constant. It is easily seen that $w_3(\lambda, \ell) \neq 0$ as $\varphi_3'(\lambda, \ell) = 0$. So we obtain $C = 0$, and hence $w = \varphi = 0$, i.e., $Y = 0$. This is a contradiction. Therefore the proof is complete. \square

3 Auxiliary operator and its spectral property

In order to investigate the Riesz basis property of the generalized eigenvector system of \mathcal{A} , we define an auxiliary operator \mathcal{A}_0 in \mathcal{H} by

$$\mathcal{A}_0 \begin{pmatrix} w \\ z \\ \varphi \\ \psi \end{pmatrix} = \begin{pmatrix} z \\ \frac{K}{\rho}w'' \\ \psi \\ \frac{EI}{I\rho}\varphi'' \end{pmatrix}, \quad (3.1)$$

$$\mathcal{D}(\mathcal{A}_0) = \left\{ [w, z, \varphi, \psi]^\top \in \mathcal{H} \mid w \in V_0^2, z \in V_0^1, \varphi \in H^2(0, \ell), \right. \\ \left. \psi \in H^1(0, \ell), \psi(0) = r\varphi'(0), \varphi'(\ell) = 0, w'(\ell) = -\beta z(\ell), \right\}. \quad (3.2)$$

In the rest of this section, we study the property of \mathcal{A}_0 . In the sequel, we denote by Z the set of all integers, and always assume that $\rho_1 \neq \rho_2$.

Theorem 3.1. Let \mathcal{A}_0 be defined by (3.1) and (3.2). Assume that $1 \neq r\rho_2, \beta \neq \rho_1$, and set

$$\tau_1 = \begin{cases} \frac{1}{2\ell} \ln \left| \frac{\rho_1 - \beta}{\rho_1 + \beta} \right|, & \text{if } \beta - \rho_1 > 0, \\ \frac{1}{2\ell} \ln \left| \frac{\rho_1 - \beta}{\rho_1 + \beta} \right| + \frac{i\pi}{2\ell}, & \text{if } \beta - \rho_1 < 0, \end{cases} \quad (3.3)$$

$$\tau_2 = \begin{cases} \frac{1}{2\ell} \ln \left| \frac{r\rho_2 - 1}{r\rho_2 + 1} \right|, & \text{if } r\rho_2 - 1 > 0, \\ \frac{1}{2\ell} \ln \left| \frac{r\rho_2 - 1}{r\rho_2 + 1} \right| + \frac{i\pi}{2\ell}, & \text{if } r\rho_2 - 1 < 0. \end{cases} \quad (3.4)$$

Then

1) the spectrum $\sigma(\mathcal{A}_0)$ of \mathcal{A}_0 consists of all eigenvalues of \mathcal{A}_0 , and is decomposed into two branches:

$$\sigma(\mathcal{A}_0) = \{\xi_n \mid n \in Z\} \cup \{\eta_n \mid n \in Z\} \cup \{0\},$$

where

$$\rho_1 \xi_n = \tau_1 + i \frac{n\pi}{\ell}, \quad \rho_2 \eta_n = \tau_2 + i \frac{n\pi}{\ell}, \quad \forall n \in Z;$$

2) an eigenvector of \mathcal{A}_0 associated with ξ_n is

$$\Psi_n = \left[\xi_n^{-1} \sinh(\rho_1 \xi_n x), \sinh(\rho_1 \xi_n x), 0, 0 \right]^\top, \quad n \in Z, \quad (3.5)$$

and similarly, an eigenvector of \mathcal{A}_0 corresponding to η_n is

$$\Phi_n = \left[0, 0, \eta_n^{-1} [\sinh(\rho_2 \eta_n x) + r \rho_2 \cosh(\rho_2 \eta_n x)], \sinh(\rho_2 \eta_n x) + r \rho_2 \cosh(\rho_2 \eta_n x) \right]^\top. \quad (3.6)$$

An eigenvector of \mathcal{A}_0 corresponding to 0 is

$$F_0 = [0, 0, 1, 0]^\top; \quad (3.7)$$

3) the adjoint operator \mathcal{A}_0^* of \mathcal{A}_0 is given by

$$\mathcal{A}_0^* \begin{pmatrix} w(x) \\ z(x) \\ \varphi(x) \\ \psi(x) \end{pmatrix} = \begin{pmatrix} -z(x) \\ -\frac{K}{\rho} w''(x) \\ -(\psi(x) - \psi(0)) \\ -\frac{EI}{I_\rho} \varphi''(x) \end{pmatrix} \quad (3.8)$$

$$\mathcal{D}(\mathcal{A}_0^*) = \left\{ [w, z, \varphi, \psi]^\top \in \mathcal{H} \mid w \in V_0^2, z \in V_0^1, \varphi \in H^2, \psi \in H^1 \right. \\ \left. w'(\ell) = \beta z(\ell), \psi(0) = -r \varphi'(0), \varphi'(\ell) = 0 \right\}. \quad (3.9)$$

4) the spectrum $\sigma(\mathcal{A}_0^*)$ of \mathcal{A}_0^* is $\sigma(\mathcal{A}_0^*) = \overline{\sigma(\mathcal{A}_0)} = \sigma(\mathcal{A}_0)$. Moreover, if we set

$$\Psi_n^* = [\bar{\xi}_n^{-1} \sinh(\rho_1 \bar{\xi}_n x), -\sinh(\rho_1 \bar{\xi}_n x), 0, 0]^\top, \quad n \in Z,$$

$$\Phi_n^* = \left[0, 0, \bar{\eta}_n^{-1} [\sinh(\rho_2 \bar{\eta}_n x) + r \rho_2 (\cosh(\rho_2 \bar{\eta}_n x) - 1)], -[\sinh(\rho_2 \bar{\eta}_n x) + r \rho_2 \cosh(\rho_2 \bar{\eta}_n x)] \right]^\top,$$

$$F_0^* = [0, 0, 1, r]^\top,$$

then $\{\Psi_n^*, \Phi_n^*, F_0^* \mid n \in Z\}$ is the eigenvector system of \mathcal{A}_0^* .

Proof We consider the eigenvalue problem of \mathcal{A}_0 . Let $\lambda \in \mathbb{C}$ be an eigenvalue of \mathcal{A}_0 , and $Y = [w, z, \varphi, \psi]^\top \in \mathcal{H}$ be an eigenvector of \mathcal{A}_0 corresponding to λ . Then $w(x)$ and $\varphi(x)$ satisfy

$$\begin{cases} \rho \lambda^2 w(x) - K w''(x) = 0, & 0 < x < \ell, \\ I_\rho \lambda^2 \varphi(x) - EI \varphi''(x) = 0, & 0 < x < \ell, \\ w(0) = 0, & \lambda \varphi(0) = r \varphi'(0), \\ w'(\ell) = -\beta \lambda w(\ell), & \varphi'(\ell) = 0. \end{cases} \quad (3.10)$$

Solving above equations, we obtain that

$$w(x) = B \sinh(\rho_1 \lambda x), \quad \varphi(x) = C [\sinh(\rho_2 \lambda x) + r \rho_2 \cosh(\rho_2 \lambda x)],$$

where B and C are constants. From the boundary condition of (3.10) it follows that

$$B[\rho_1 \lambda \cosh(\rho_1 \lambda \ell) + \beta \lambda \sinh(\rho_1 \lambda \ell)] = 0, \quad (3.11)$$

and

$$C[\lambda \cosh(\rho_2 \lambda \ell) + r \rho_2 \lambda \sinh(\rho_2 \lambda \ell)] = 0. \quad (3.12)$$

If $C = 0$ and $\beta \neq \rho_1$, then when $\lambda = 0$, the equation (3.10) has a unique zero solution. As $\lambda \neq 0$, by solving equation (3.11) we get

$$\lambda = \xi_n = \begin{cases} \frac{1}{2\rho_1 \ell} \ln \left| \frac{\beta - \rho_1}{\beta + \rho_1} \right| + i \frac{n\pi}{\rho_1 \ell}, & \text{if } \beta - \rho_1 > 0, \\ \frac{1}{2\rho_1 \ell} \ln \left| \frac{\beta - \rho_1}{\beta + \rho_1} \right| + i \frac{(2n+1)\pi}{2\rho_1 \ell}, & \text{if } \beta - \rho_1 < 0, \end{cases} \quad \forall n \in Z. \quad (3.13)$$

If $B = 0$ and $r\rho_2 \neq 1$, then for $\lambda = 0$, the equation (3.10) has a nonzero solution $\varphi(x) = 1$. For $\lambda \neq 0$, from (3.12) we obtain

$$\lambda = \eta_n = \begin{cases} \frac{1}{2\rho_2 \ell} \ln \left| \frac{r\rho_2 - 1}{r\rho_2 + 1} \right| + i \frac{n\pi}{\rho_2 \ell}, & \text{if } r\rho_2 - 1 > 0, \\ \frac{1}{2\rho_2 \ell} \ln \left| \frac{r\rho_2 - 1}{r\rho_2 + 1} \right| + i \frac{(2n+1)\pi}{2\rho_2 \ell}, & \text{if } r\rho_2 - 1 < 0, \end{cases} \quad \forall n \in Z. \quad (3.14)$$

So the point spectrum $\sigma_p(\mathcal{A}_0)$ of \mathcal{A}_0 is

$$\sigma_p(\mathcal{A}_0) = \{\xi_n \mid n \in Z\} \cup \{\eta_n \mid n \in Z\} \cup \{0\}.$$

It is easily to check that if $\lambda \notin \sigma_p(\mathcal{A}_0)$, then $\lambda \in \rho(\mathcal{A}_0)$, and so $\sigma(\mathcal{A}_0) = \sigma_p(\mathcal{A}_0)$.

Moreover, $\lambda = 0$ is a simple eigenvalue of \mathcal{A}_0 , and a corresponding eigenvector is $F_0 = [0, 0, 1, 0]$.

For $\xi_n \in \sigma(\mathcal{A}_0)$, a corresponding eigenvector is

$$\Psi_n = \left[\xi_n^{-1} \sinh(\rho_1 \xi_n x), \sinh(\rho_1 \xi_n x), 0, 0 \right]^\top,$$

and for $\eta_n \in \mathcal{A}_0$, a corresponding eigenvector is

$$\Phi_n = \left[0, 0, \eta_n^{-1} [\sinh(\rho_2 \eta_n x) + r\rho_2 \cosh(\rho_2 \eta_n x)], (\sinh(\rho_2 \eta_n x) + r\rho_2 \cosh(\rho_2 \eta_n x)) \right]^\top.$$

The assertions 3) and 4) are direct. The proof is then complete. \square

Theorem 3.2. Let \mathcal{H}_1 and \mathcal{H}_2 be two subspaces of \mathcal{H} defined by

$$\mathcal{H}_1 = \{F = [w, z, 0, 0]^\top \mid F \in \mathcal{H}\},$$

$$\mathcal{H}_2 = \{F = [0, 0, \varphi, \psi]^\top \mid F \in \mathcal{H}\}.$$

Assume that τ_1, τ_2, ξ_n and η_n are defined as in Theorem 3.1. Then $\{\Psi_n \mid n \in Z\}$ forms a Riesz basis of \mathcal{H}_1 , and $\{\Phi_n \mid n \in Z\} \cup \{F_0\}$ forms a Riesz basis of \mathcal{H}_2 . Hence $\{\Psi_n \mid n \in Z\} \cup \{\Phi_n \mid n \in Z\} \cup \{F_0\}$ forms a Riesz basis of \mathcal{H} .

Proof By virtue of Theorem 3.1, it is easily seen that for any $n, m \in Z$,

$$\begin{aligned}\langle F_0^*, \Psi_n \rangle &= \langle F_0^*, \Phi_n \rangle = \langle \Phi_n^*, F_0 \rangle = \langle \Psi_n^*, F_0 \rangle = 0, \\ &= \langle \Phi_n^*, \Psi_m \rangle = \langle \Psi_n^*, \Phi_m \rangle = 0, \quad \forall n \neq m, \\ \langle \Phi_n, \Phi_n^* \rangle &= I_\rho(1 + r^2 \rho_2^2) \ell, \quad \langle \Psi_n, \Psi_n^* \rangle = \rho \ell, \quad \langle F_0^*, F_0 \rangle = EI.\end{aligned}$$

Now we prove that $\{\Phi_n \mid n \in Z\} \cup \{F_0\}$ forms a Riesz basis of \mathcal{H}_2 . To this end, for any $Y \in \mathcal{H}_2$, we define $a_n(Y)$ by

$$\begin{aligned}I_\rho(1 + r^2 \rho_2^2) \ell a_n(Y) &= \langle Y, \Phi_n^* \rangle \\ &= EI \int_0^\ell \rho_2 \varphi'(x) [\cosh(\rho_2 \bar{\eta}_n x) + r \rho_2 \sinh(\rho_2 \bar{\eta}_n x)] dx \\ &\quad - I_\rho \int_0^\ell \psi(x) [\sinh(\rho_2 \bar{\eta}_n x) + r \rho_2 \cosh(\rho_2 \bar{\eta}_n x)] dx \\ &= \frac{\ell}{2} EI \rho_2 \left[\mathcal{F}_{c,n}(\varphi'[\cosh(\tau_2 \cdot) + r \rho_2 \sinh(\tau_2 \cdot)]) + i \mathcal{F}_{s,n}(\varphi'[\sinh(\tau_2 \cdot) + r \rho_2 \cosh(\tau_2 \cdot)]) \right] \\ &\quad - \frac{\ell}{2} I_\rho \left[\mathcal{F}_{c,n}(\psi[\sinh(\tau_2 \cdot) + r \rho_2 \cosh(\tau_2 \cdot)]) + i \mathcal{F}_{s,n}(\psi[\cosh(\tau_2 \cdot) + r \rho_2 \sinh(\tau_2 \cdot)]) \right],\end{aligned}$$

where $\mathcal{F}_{c,n}(g)$ and $\mathcal{F}_{s,n}(g)$ represent the Fourier coefficients of g :

$$\begin{aligned}\mathcal{F}_{c,n}(g) &= \frac{2}{\ell} \int_0^\ell g(x) \cos\left(\frac{n\pi x}{\ell}\right) dx, \\ \mathcal{F}_{s,n}(g) &= \frac{2}{\ell} \int_0^\ell g(x) \sin\left(\frac{n\pi x}{\ell}\right) dx.\end{aligned}$$

Noticing that $\{\cos(\frac{n\pi x}{\ell}) \mid n \geq 0\}$ and $\{\sin(\frac{n\pi x}{\ell}) \mid n \geq 1\}$ are two normalized bases in $L^2[0, \ell]$, then we have

$$\sum_{n=0}^{\infty} |\mathcal{F}_{c,n}(g)|^2 < \infty, \quad \sum_{n=1}^{\infty} |\mathcal{F}_{s,n}(g)|^2 < \infty.$$

Therefore

$$\sum_{-\infty}^{\infty} |a_n(Y)|^2 < \infty.$$

We define the subspace \mathcal{H}_0 of \mathcal{H}_2 by

$$\mathcal{H}_0 = \left\{ Y \in \mathcal{H}_2 \mid Y = \sum_{-\infty}^{\infty} a_n(Y) \Phi_n(x) + \langle Y, F_0^* \rangle F_0 \right\}.$$

Obviously, \mathcal{H}_0 is closed. If $\mathcal{H}_0 \neq \mathcal{H}_2$, then there exists a $Y_0 \in \mathcal{H}_2$, $Y_0 = [0, 0, \varphi(x), \psi(x)]^\top \neq 0$, such that $Y_0 \perp \mathcal{H}_0$. So $Y_0 \perp F_0$, $Y_0 \perp \Phi_n, \forall n \in Z$. The equality $\langle Y_0, F_0 \rangle = 0$ implies that $\varphi(0) = 0$. Then we define

$$\mathcal{G}_1(\varphi)(x) = \begin{cases} \varphi(x), & \text{if } x \in [0, \ell], \\ \varphi(-x), & \text{if } x \in [-\ell, 0], \end{cases}$$

and

$$\mathcal{G}_2(\psi)(x) = \begin{cases} \psi(x), & \text{if } x \in [0, \ell], \\ -\psi(-x), & \text{if } x \in [-\ell, 0]. \end{cases}$$

We have

$$\begin{aligned} \langle Y_0, \Phi_n \rangle &= EI \int_0^\ell \varphi' \rho_2 [\cosh(\rho_2 \eta_n x) + r \rho_2 \sinh(\rho_2 \eta_n x)] dx \\ &\quad + I_\rho \int_0^\ell \psi(x) \sinh(\rho_2 \eta_n x) r \rho_2 \cosh(\rho_2 \eta_n x) dx \\ &= \frac{EI \rho_2}{2} \int_{-\ell}^\ell \mathcal{G}_1(\varphi')(x) e^{\rho_2 \bar{\eta}_n x} dx + \frac{EI r \rho_2^2}{2} \int_{-\ell}^\ell \mathcal{G}_2(\varphi')(x) e^{\rho_2 \bar{\eta}_n x} dx \\ &\quad + \frac{I_\rho}{2} \int_{-\ell}^\ell \mathcal{G}_2(\psi)(x) e^{\rho_2 \bar{\eta}_n x} + \frac{I_\rho r \rho_2}{2} \int_{-\ell}^\ell \mathcal{G}_1(\psi)(x) e^{\rho_2 \bar{\eta}_n x} dx = 0. \end{aligned}$$

This implies that

$$\begin{aligned} \frac{EI \rho_2}{2} \varphi'(x) + \frac{EI r \rho_2^2}{2} \varphi'(x) + \frac{I_\rho}{2} \psi(x) + \frac{I_\rho r \rho_2}{2} \psi(x) &= 0, \quad a.e., \quad x \in [0, \ell], \\ \frac{EI \rho_2}{2} \varphi'(x) - \frac{EI r \rho_2^2}{2} \varphi'(x) - \frac{I_\rho}{2} \psi(x) + \frac{I_\rho r \rho_2}{2} \psi(x) &= 0, \quad a.e., \quad x \in [0, \ell]. \end{aligned}$$

Solving the above algebraic equations, we obtain that $\varphi'(x) = 0$ and $\psi(x) = 0$. Therefore $\varphi(x) = \psi(x) = 0$, which contradicts to the hypothesis $Y_0 \neq 0$. So we have $\mathcal{H}_0 = \mathcal{H}_2$.

A similar argument can be used to prove that $\{\Psi_n \mid n \in Z\}$ forms a Riesz basis of \mathcal{H}_1 . Noting that $\mathcal{H} = \mathcal{H}_1 + \mathcal{H}_2$, we conclude that $\{\Psi_n \mid n \in Z\} \cup \{\Phi_n \mid n \in Z\} \cup \{F_0\}$ forms a Riesz basis of \mathcal{H} . The proof is then finished. \square

Corollary 3.3. If $\rho_1 = \beta, r \rho_2 = 1$, then the spectrum $\sigma(\mathcal{A}_0)$ of \mathcal{A}_0 has only one element $\lambda = 0$.

Proof Obviously, $\lambda = 0$ is always an eigenvalue of \mathcal{A}_0 if $\beta = \rho_1, r \rho_2 = 1$. On the other hand, for any $\lambda \in \mathbb{C}, \lambda \neq 0$, (3.11) and (3.12) with $B \neq 0$ or $C \neq 0$ can not hold. So $\sigma(\mathcal{A}_0)$ has a unique element $\lambda = 0$. \square

4 Riesz basis property of generalized eigenvector system of operator \mathcal{A}

In this section we prove that the generalized eigenvector system of \mathcal{A} forms a Riesz basis in \mathcal{H} . To begin with, we recall some notions and Bari's theorem. Let \mathcal{H} be a separable Hilbert space, and $\{e_n \mid n \geq 1\}$ be a normalized basis of \mathcal{H} . A sequence of vectors, $\{f_j \mid j \geq 1\}$ in \mathcal{H} , is said to be a Riesz basis of \mathcal{H}

if there exists a bounded invertible linear operator T in \mathcal{H} such that $f_n = Te_n$ for all $n \geq 1$. Bari's theorem (e.g, see, Yuong, 1980) says that if an ω -linear independent sequence $\{f_n \mid n \geq 1\}$ in \mathcal{H} is quadratically near to a Riesz basis $\{g_n \mid n \geq 1\}$ in \mathcal{H} , i.e.,

$$\sum_{n=0}^{\infty} \|g_n - f_n\|^2 < \infty,$$

then $\{f_n \mid n \geq 1\}$ is a Riesz basis of \mathcal{H} . The following result can be found in Guo, 2001.

Proposition 4.1. Let \mathcal{A} be a closed dense defined linear operator in \mathcal{H} . Assume that \mathcal{A} is discrete, i.e., \mathcal{A} has compact resolvent. Let $\{f_n \mid n \geq 1\}$ be a Riesz basis of \mathcal{H} . If there exists a sequence of generalized eigenvectors of \mathcal{A} , $\{g_n \mid n \geq 1\}$ and a positive integer N such that

$$\sum_{n=N}^{\infty} \|f_n - g_n\|^2 < \infty, \quad (4.1)$$

then the system of all generalized eigenvectors of \mathcal{A} forms a Riesz basis of \mathcal{H} .

Now we are in position to prove the following main result of this paper.

Theorem 4.2. Let \mathcal{H} and \mathcal{A} be defined as before, then the generalized eigenvector system forms a Riesz basis for \mathcal{H} .

Before going to the detail of the proof of theorem, we give the outline of the proof. Let $w_j(\lambda, x)$, $\varphi_j(\lambda, x)$, $j = 2, 3, 4$ be defined by (2.8). Then for fixed $\lambda \in \mathbb{C}$, set

$$Y_j(\lambda) = [\lambda^{-1}w_j(\lambda, x), w_j(\lambda, x), \lambda^{-1}\varphi_j(\lambda, x), \varphi(\lambda, x)]^\top, j = 2, 3, 4. \quad (4.2)$$

Let $\lambda_n^{(1)}$ and $\lambda_n^{(2)}$ be the eigenvalues of \mathcal{A} given by (2.14) and (2.15) respectively. According to (2.12) in theorem 2.2, the eigenvector associated with $\lambda_n^{(j)}$ is

$$\Phi^{(j)}(\lambda_n^{(j)}) = C_2^{(j)}(\lambda_n^{(j)})[Y_2(\lambda_n^{(j)}) + \frac{\lambda + r}{r}Y_4(\lambda_n^{(j)})] + C_3^{(j)}(\lambda_n^{(j)})Y_3(\lambda_n^{(j)}), \quad j = 1, 2, \quad (4.3)$$

where $C_2^{(j)}, C_3^{(j)}$ satisfy (2.13) for $\lambda = \lambda_n^{(j)}$.

Let $\Phi_n = \Phi_{\xi_n}$, $\Psi_n = \Psi_{\eta_n}$ and F_0 be defined by (3.5), (3.6) and (3.7), respectively. We now choose $\{B_n^{(1)}\Phi_n, B_n^{(2)}\Psi_n, F_0, \mid n \in Z\}$ as a reference Riesz basis of \mathcal{H} , where $B_n^{(1)}$ and $B_n^{(2)}$ are some constants. We want to prove that with suitable choice of $B_n^{(1)}$ and $B_n^{(2)}$, there exist a positive integer N such that

$$\sum_{|n| > N} \|\Phi^{(1)}(\lambda_n^{(1)}) - B_n^{(1)}\Psi_{\xi_n}\|^2 < \infty$$

$$\sum_{|n|>N}^{\infty} \|\Phi^{(2)}(\lambda_n^{(2)}) - B_n^{(2)}\Phi_{\eta_n}\|^2 < \infty.$$

Proof of Theorem 4.2 Assume without loss of generality that $\rho_1 > \rho_2$. Then for $\lambda \in \mathbb{C}$ with $|\lambda|$ large enough, we have

$$\begin{aligned}\sqrt{\mu_1(\lambda)} &= \rho_1\lambda + O(\lambda^{-1}), \\ \sqrt{\mu_2(\lambda)} &= \rho_2\lambda + O(\lambda^{-1}).\end{aligned}$$

Particularly, for $\lambda = \lambda_n^{(1)}$, we have

$$\begin{aligned}\sqrt{\mu_1(\lambda_n^{(1)})} &= \rho_1\lambda_n^{(1)} + O(1/n) = \rho_1\xi_n + O(1/n), \\ \sqrt{\mu_2(\lambda_n^{(1)})} &= \rho_2\lambda_n^{(1)} + O(1/n) = \rho_2\xi_n + O(1/n),\end{aligned}$$

Similarly, for $\lambda = \lambda_n^{(2)}$, we have

$$\begin{aligned}\sqrt{\mu_1(\lambda_n^{(2)})} &= \rho_1\lambda_n^{(2)} + O(1/n) = \rho_1\eta_n + O(1/n), \\ \sqrt{\mu_2(\lambda_n^{(2)})} &= \rho_2\lambda_n^{(2)} + O(1/n) = \rho_2\eta_n + O(1/n).\end{aligned}$$

Firstly, we choose the coefficient $C_2^{(j)}(\lambda)$ and $C_3^{(j)}(\lambda)$ in the expression of eigenvector (4.3) as follows:

$$C_2^{(1)}(\lambda) = \varphi_3'(\lambda, \ell), \quad C_3^{(1)}(\lambda) = -\left[\varphi_2'(\lambda, \ell) + \frac{\lambda+r}{r}\varphi_4'(\lambda, \ell)\right]. \quad (4.4)$$

$$C_2^{(2)}(\lambda) = w_3'(\lambda, \ell) - \varphi_3(\lambda, \ell) + \beta\lambda w_3(\lambda, \ell), \quad (4.5)$$

and

$$\begin{aligned}C_3^{(2)}(\lambda) &= -\left[w_2'(\lambda, \ell) - \varphi_2(\lambda, \ell) + \beta\lambda w_2(\lambda, \ell) \right. \\ &\quad \left. + \frac{\lambda+r}{r}[w_4'(\lambda, \ell) - \varphi_4(\lambda, \ell) + \beta\lambda w_4(\lambda, \ell)]\right].\end{aligned} \quad (4.6)$$

Now for $\lambda \in \mathbb{C}$ with large modulus, we have the following estimates

$$\begin{aligned}|w_2'(\lambda, x)| &= O(1), & |w_4'(\lambda, x)| &= O(1/\lambda), & |w_3'(\lambda, x)| &= O(1), \\ |\lambda w_2(\lambda, x)| &= O(1), & |\lambda w_4(\lambda, x)| &= O(1/\lambda), & |\lambda w_3(\lambda, x)| &= O(1), \\ |\varphi_2'(\lambda, x)| &= O(\lambda), & |\varphi_4'(\lambda, x)| &= O(1), & |\varphi_3'(\lambda, x)| &= O(1/\lambda), \\ |\lambda\varphi_2'(\lambda, x)| &= O(\lambda), & |\lambda\varphi_4'(\lambda, x)| &= O(1), & |\lambda\varphi_3'(\lambda, x)| &= O(1/\lambda).\end{aligned}$$

This leads to that

$$\|Y_2(\lambda)\| = O(1), \quad \|Y_3(\lambda)\| = O(1/\lambda), \quad \|Y_4(\lambda)\| = O(1/\lambda).$$

Since $\sqrt{\mu_1(\lambda_n^{(1)})} = \rho_1\xi_n + O(1/n)$, we have

$$C_2^{(1)}(\lambda_n^{(1)}) = O(1/\lambda_n^{(1)}), \quad C_3^{(1)}(\lambda_n^{(1)}) = O(\lambda_n^{(1)})$$

Similarly, we have $\sqrt{\mu_2(\lambda_n^{(2)})} = \rho_2 \eta_n + O(1/n)$, and

$$C_2^{(2)}(\lambda_n^{(2)}) = O(1), \quad C_3^{(2)}(\lambda_n^{(2)}) = O(1).$$

Therefore, $\Phi^{(1)}(\lambda_n^{(1)})$ is expressed as

$$\begin{aligned} \Phi^{(1)}(\lambda_n^{(1)}) &= C_2^{(1)}(\lambda_n^{(1)})[Y_2(\lambda_n^{(1)}) + \frac{\lambda_n^{(1)} + r}{r} Y_4(\lambda_n^{(1)})] + C_3^{(1)}(\lambda_n^{(1)})Y_3(\lambda_n^{(1)}) \\ &= \frac{C_3^{(1)}(\lambda_n^{(1)})}{\lambda_n^{(1)}} \begin{pmatrix} \frac{\mu_1(\lambda_n^{(1)}) - b(\lambda_n^{(1)})}{\mu_1(\lambda_n^{(1)}) - \mu_2(\lambda_n^{(1)})} \frac{1}{\sqrt{\mu_1(\lambda_n^{(1)})}} \sinh(\sqrt{\mu_1(\lambda_n^{(1)})}x) \\ \frac{\mu_1(\lambda_n^{(1)}) - b(\lambda_n^{(1)})}{\mu_1(\lambda_n^{(1)}) - \mu_2(\lambda_n^{(1)})} \frac{\lambda_n^{(1)}}{\sqrt{\mu_1(\lambda_n^{(1)})}} \sinh(\sqrt{\mu_1(\lambda_n^{(1)})}x) \\ 0 \\ 0 \end{pmatrix} + G_1(\lambda_n^{(1)}). \end{aligned}$$

where $C_2^{(1)}(\lambda)$ and $C_3^{(1)}(\lambda)$ are given by (4.4), and $G_1(\lambda_n^{(1)})$ is given by

$$\begin{aligned} G_1(\lambda) &= \frac{C_3^{(1)}(\lambda)}{\lambda} \begin{pmatrix} -\frac{\mu_2(\lambda) - b(\lambda)}{\mu_1(\lambda) - \mu_2(\lambda)} \frac{1}{\sqrt{\mu_2(\lambda)}} \sinh(\sqrt{\mu_2(\lambda)}x) \\ -\frac{\mu_2(\lambda) - b(\lambda)}{\mu_1(\lambda) - \mu_2(\lambda)} \frac{\lambda}{\sqrt{\mu_2(\lambda)}} \sinh(\sqrt{\mu_2(\lambda)}x) \\ \varphi_3(\lambda, x) \\ \lambda \varphi_3(\lambda, x) \end{pmatrix} \\ &\quad + C_2^{(1)}(\lambda) \left(Y_2(\lambda) + \frac{\lambda + r}{r} Y_4(\lambda) \right), \end{aligned}$$

with the estimate $\|G_1(\lambda_n^{(1)})\| = O(1/\lambda_n^{(1)})$.

Similarly, the eigenvector $\Phi^{(2)}(\lambda_n^{(2)})$ is expressed as

$$\begin{aligned} \Phi^{(2)}(\lambda_n^{(2)}) &= C_2^{(2)}(\lambda_n^{(2)})[Y_2(\lambda_n^{(2)}) + \frac{\lambda_n^{(2)} + r}{r} Y_4(\lambda_n^{(2)})] + C_3^{(2)}(\lambda_n^{(2)})Y_3(\lambda_n^{(2)}) \\ &= C_2^{(2)}(\lambda_n^{(2)}) \begin{pmatrix} 0 \\ 0 \\ \frac{\mu_1 - b}{\lambda(\mu_1 - \mu_2)} \cosh(\sqrt{\mu_2}x) + \frac{\mu_1 - b}{\mu_1 - \mu_2} \frac{1}{r\sqrt{\mu_2}} \sinh(\sqrt{\mu_2}x) \\ \frac{\mu_1 - b}{\mu_1 - \mu_2} \cosh(\sqrt{\mu_2}x) + \frac{\mu_1 - b}{\mu_1 - \mu_2} \frac{\lambda}{r\sqrt{\mu_2}} \sinh(\sqrt{\mu_2}x) \end{pmatrix} \Big|_{\lambda = \lambda_n^{(2)}} \\ &\quad + G_2(\lambda_n^{(2)}). \end{aligned}$$

where $C_2^{(2)}(\lambda)$ and $C_3^{(2)}(\lambda)$ are given by (4.5) and (4.6) respectively, and $G_2(\lambda)$ is given by

$$G_2(\lambda) = C_3^{(2)}(\lambda)Y_3(\lambda) + C_2^{(2)}(\lambda)Y_4(\lambda) + C_2^{(2)}(\lambda) \begin{pmatrix} \frac{1}{\lambda} [w_2(\lambda, x) + \frac{\lambda}{r} w_4(\lambda, x)] \\ w_2(x) + \frac{\lambda}{r} w_4(\lambda, x) \\ p_3(\lambda) \\ p_4(\lambda), \end{pmatrix},$$

where

$$\begin{aligned}
p_3(\lambda) &= -\frac{\mu_2(\lambda) - b(\lambda)}{\lambda(\mu_1(\lambda) - \mu_2(\lambda))} \cosh(\sqrt{\mu_1(\lambda)}x) + \frac{\mu_1(\lambda) - a(\lambda)}{\mu_1(\lambda) - \mu_2(\lambda)} \frac{1}{r\sqrt{\mu_1(\lambda)}} \sinh(\sqrt{\mu_1(\lambda)}x) \\
&\quad - \frac{c}{\mu_1(\lambda) - \mu_2(\lambda)} \frac{1}{r\sqrt{\mu_1(\lambda)}} \sinh(\sqrt{\mu_1(\lambda)}x), \\
p_4(\lambda) &= -\frac{\mu_2(\lambda) - b(\lambda)}{\mu_1(\lambda) - \mu_2(\lambda)} \cosh(\sqrt{\mu_1(\lambda)}x) + \frac{\mu_1(\lambda) - a(\lambda)}{\mu_1(\lambda) - \mu_2(\lambda)} \frac{\lambda}{r\sqrt{\mu_1(\lambda)}} \sinh(\sqrt{\mu_1(\lambda)}x) \\
&\quad - \frac{c}{\mu_1(\lambda) - \mu_2(\lambda)} \frac{\lambda}{r\sqrt{\mu_1(\lambda)}} \sinh(\sqrt{\mu_1(\lambda)}x).
\end{aligned}$$

Moreover, we have the estimate $\|G_2(\lambda_n^{(2)})\| = O(1/\lambda_n^{(2)})$.

Set

$$\widehat{\Psi}(\lambda) = \frac{C_3^{(1)}(\lambda)}{\lambda} \begin{pmatrix} \frac{\mu_1(\lambda) - b(\lambda)}{\mu_1(\lambda) - \mu_2(\lambda)} \frac{1}{\sqrt{\mu_1(\lambda)}} \sinh(\sqrt{\mu_1(\lambda)}x) \\ \frac{\mu_1(\lambda) - b(\lambda)}{\mu_1(\lambda) - \mu_2(\lambda)} \frac{\lambda}{\sqrt{\mu_1(\lambda)}} \sinh(\sqrt{\mu_1(\lambda)}x) \\ 0 \\ 0 \end{pmatrix},$$

and

$$\widehat{\Phi}(\lambda) = C_2^{(2)}(\lambda) \begin{pmatrix} 0 \\ 0 \\ \frac{\mu_1 - b}{\lambda(\mu_1 - \mu_2)} \cosh(\sqrt{\mu_2}x) + \frac{\mu_1 - b}{\mu_1 - \mu_2} \frac{1}{r\sqrt{\mu_2}} \sinh(\sqrt{\mu_2}x) \\ \frac{\mu_1 - b}{\mu_1 - \mu_2} \cosh(\sqrt{\mu_2}x) + \frac{\mu_1 - b}{\mu_1 - \mu_2} \frac{\lambda_n^{(2)}}{r\sqrt{\mu_2}} \sinh(\sqrt{\mu_2}x) \end{pmatrix} \Big|_{\mu_j = \mu_j(\lambda)}.$$

Then we have

$$\Phi^{(1)}(\lambda_n^{(1)}) = \widehat{\Psi}(\lambda_n^{(1)}) + G_1(\lambda_n^{(1)}), \quad \Phi^{(2)}(\lambda_n^{(2)}) = \widehat{\Phi}(\lambda_n^{(2)}) + G_2(\lambda_n^{(2)}).$$

In order to estimate the vectors $\widehat{\Psi}(\lambda^{(1)})$ and $\widehat{\Phi}(\lambda_n^{(2)})$, we denote

$$A(\lambda) = \frac{\mu_1(\lambda) - b(\lambda)}{\mu_1(\lambda) - \mu_2(\lambda)}.$$

Thus

$$\widehat{\Psi}(\lambda_n^{(1)}) = A(\lambda_n^{(1)}) \frac{C_3^{(1)}(\lambda_n^{(1)})}{\lambda_n^{(1)}} \begin{pmatrix} \frac{1}{\sqrt{\mu_1(\lambda_n^{(1)})}} \sinh(\sqrt{\mu_1(\lambda_n^{(1)})}x) \\ \frac{\lambda_n^{(1)}}{\sqrt{\mu_1(\lambda_n^{(1)})}} \sinh(\sqrt{\mu_1(\lambda_n^{(1)})}x) \\ 0 \\ 0 \end{pmatrix},$$

and

$$\widehat{\Phi}(\lambda_n^{(2)}) = A(\lambda_n^{(2)}) C_2^{(2)}(\lambda_n^{(2)}) \begin{pmatrix} 0 \\ 0 \\ q_3(\lambda_n^{(2)}) \\ q_4(\lambda_n^{(2)}) \end{pmatrix},$$

where

$$q_3(\lambda) = \frac{1}{\lambda} \cosh(\sqrt{\mu_2(\lambda)}x) + \frac{1}{r\sqrt{\mu_2(\lambda)}} \sinh(\sqrt{\mu_2(\lambda)}x),$$

$$q_4(\lambda) = \cosh(\sqrt{\mu_2(\lambda)}x) + \frac{\lambda}{r\sqrt{\mu_2(\lambda)}} \sinh(\sqrt{\mu_2(\lambda)}x).$$

Set

$$B_n^{(1)} := A(\lambda_n^{(1)}) \frac{C_3^{(1)}(\lambda_n^{(1)})}{\lambda_n^{(1)}}, \quad B_n^{(2)} := A(\lambda_n^{(2)}) C_2^{(2)}(\lambda_n^{(2)}),$$

$$\alpha_n^{(1)} := \sqrt{\mu_1(\lambda_n^{(1)})} - \rho_1 \xi_n, \quad \alpha_n^{(2)} := \sqrt{\mu_2(\lambda_n^{(2)})} - \rho_2 \eta_n.$$

Obviously, $\alpha_n^{(j)} = O(1/n)$ for $j = 1, 2$.

Now let Ψ_n and Φ_n be defined as in Theorem 3.1. Then, when $|n| \geq N$, we have

$$\begin{aligned} & \left\| \widehat{\Psi}(\lambda_n^{(1)}) - B_n^{(1)} \Psi_n \right\|^2 \\ &= |B_n^{(1)}|^2 \left[\int_0^\ell K \left| \cosh(\sqrt{\mu_1}x) - \cosh(\rho_1 \xi_n x) \right|^2 dx \right. \\ & \quad \left. + \int_0^\ell \rho \left| \frac{\lambda_n^{(1)}}{\sqrt{\mu_1}} \sinh(\sqrt{\mu_1}x) - \frac{1}{\rho_1} \sinh(\rho_1 \xi_n x) \right|^2 dx \right] \\ &= |B_n^{(1)}|^2 \left[\int_0^\ell K \left[\cosh(\alpha_n^{(1)}x) - 1 \right] \cosh(\rho_1 \xi_n x) \right. \\ & \quad \left. + \sinh(\alpha_n^{(1)}x) \sinh(\rho_1 \xi_n x) \right]^2 dx + \int_0^\ell \rho \left| \frac{\lambda_n^{(1)}}{\sqrt{\mu_1}} \sinh(\alpha_n^{(1)}x) \cosh(\rho_1 \xi_n x) \right. \\ & \quad \left. - \left(\frac{\lambda_n^{(1)}}{\sqrt{\mu_1}} \cosh(\alpha_n^{(1)}x) - \frac{1}{\rho_1} \right) \sinh(\rho_1 \xi_n x) \right|^2 dx \right] \\ &\leq |B_n^{(1)}|^2 \left[K \int_0^\ell \left[\left| \cosh(\alpha_n^{(1)}x) - 1 \right|^2 + \left| \sinh(\alpha_n^{(1)}x) \right|^2 \right] \times \right. \\ & \quad \times \left[\left| \cosh(\rho_1 \xi_n x) \right|^2 + \left| \sinh(\rho_1 \xi_n x) \right|^2 \right] dx \\ & \quad \left. + \rho \int_0^\ell \left(\left| \frac{\lambda_n^{(1)}}{\sqrt{\mu_1}} \cosh(\rho_1 \xi_n x) \right|^2 + \left| \sinh(\rho_1 \xi_n x) \right|^2 \right) \times \right. \\ & \quad \left. \times \left(\left| \sinh(\alpha_n^{(1)}x) \right|^2 + \left| \frac{\lambda_n^{(1)}}{\sqrt{\mu_1}} \cosh(\alpha_n^{(1)}x) - \frac{1}{\rho_1} \right|^2 \right) dx \right] \\ &\leq M_1 |\alpha_n^{(1)}|^2 e^{2|\alpha_n^{(1)}|\ell}, \end{aligned}$$

where we have used the fact that $|B_n^{(1)}|^2$ is uniformly bounded, and

$$\left\| \widehat{\Phi}(\lambda_n^{(2)}) - \frac{B_n^{(2)}}{r\rho_2} \Phi_n \right\|^2$$

$$\begin{aligned}
&= |B_n^{(2)}|^2 \left[\int_0^\ell EI \left| \frac{\sqrt{\mu_2}}{\lambda_n^{(2)}} \sinh(\sqrt{\mu_2}x) + \frac{1}{r} \cosh(\sqrt{\mu_2}x) \right. \right. \\
&\quad \left. \left. - \frac{1}{r} [\cosh(\rho_2 \eta_n x) + r \rho_2 \sinh(\rho_2 \eta_n x)] \right|^2 dx \right. \\
&\quad \left. + \int_0^\ell I_\rho \left| \cosh(\sqrt{\mu_2}x) + \frac{\lambda}{r\sqrt{\mu_2}} \sinh(\sqrt{\mu_2}x) \right. \right. \\
&\quad \left. \left. - \frac{1}{r\rho_2} [\sinh(\rho_2 \eta_n x) + r \rho_2 \cosh(\rho_2 \eta_n x)] \right|^2 dx + EI \left| \frac{1}{\lambda_n^{(2)}} - \frac{1}{r\rho_2 \eta_n} r \rho_2 \right|^2 \right] \\
&\leq |B_n^{(2)}|^2 \left(EI \int_0^\ell \left[\left| \frac{\sqrt{\mu_2}}{\lambda_n^{(2)}} \cosh(\alpha_n^{(2)}x) - \rho_2 \right|^2 \right. \right. \\
&\quad \left. \left. + \left| \sinh(\alpha_n^{(2)}x) \right|^2 + \left| \cosh(\alpha_n^{(2)}x) - 1 \right|^2 + \left| \sinh(\alpha_n^{(2)}x) \right|^2 \right] \times \right. \\
&\quad \times \left[\left| \sinh(\rho_2 \eta_n x) \right|^2 + \left| \frac{\sqrt{\mu_2}}{\lambda_n^{(2)}} \cosh(\rho_2 \eta_n x) \right|^2 + \left| \frac{1}{r} \cosh(\rho_2 \eta_n x) \right|^2 \right. \\
&\quad \left. \left. + \left| \frac{1}{r} \sinh(\rho_2 \eta_n x) \right|^2 \right] dx + I_\rho \int_0^\ell \left[\left| \cosh(\alpha_n^{(2)}x) - 1 \right|^2 + \left| \sinh(\alpha_n^{(2)}x) \right|^2 \right. \right. \\
&\quad \left. \left. + \left| \frac{\lambda_n^{(2)}}{r\sqrt{\mu_2}} \cosh(\alpha_n^{(2)}x) - \frac{1}{r\rho_2} \right|^2 + \left| \sinh(\alpha_n^{(2)}x) \right|^2 \right] \times \right. \\
&\quad \times \left[\left| \cosh(\rho_2 \eta_n x) \right|^2 + \left| \sinh(\rho_2 \eta_n x) \right|^2 + \left| \sinh(\rho_2 \eta_n x) \right|^2 \right. \\
&\quad \left. \left. + \left| \frac{\lambda_n^{(2)}}{r\sqrt{\mu_2}} \cosh(\rho_2 \eta_n x) \right|^2 \right] dx + EI \left| \frac{1}{\lambda_n^{(2)}} - \frac{1}{r\rho_2 \eta_n} r \rho_2 \right|^2 \right) \\
&\leq M_2 |\alpha_n^{(2)}|^2 e^{2|\alpha_n^{(2)}|\ell}.
\end{aligned}$$

Note that

$$\begin{aligned}
\Phi(\lambda_n^{(1)}) - B_n^{(1)}\Psi_n &= [\widehat{\Psi}(\lambda_n^{(1)}) - B_n^{(1)}\Psi_n] + G_1(\lambda_n^{(1)}), \\
\Phi(\lambda_n^{(2)}) - B_n^{(2)}/(r\rho_2)\Phi_n &= [\widehat{\Phi}(\lambda_n^{(2)}) - B_n^{(2)}/(r\rho_2)\Phi_n] + G_2(\lambda_n^{(2)}).
\end{aligned}$$

Hence there exists a positive integer N such that when $|n| \geq N$, we have

$$\begin{aligned}
\left\| \Psi(\lambda_n^{(1)}) - B_n^{(1)}\Psi_n \right\|^2 &\leq 2 \left[M_1 |\alpha_n^{(1)}|^2 e^{2|\alpha_n^{(1)}|\ell} + \|G_1(\lambda_n^{(1)})\|^2 \right] \leq \frac{\widehat{M}_1}{n^2}, \\
\left\| \Psi(\lambda_n^{(2)}) - \frac{B_n^{(2)}}{r\rho_2}\Phi_n \right\|^2 &\leq 2 \left[M_1 |\alpha_n^{(2)}|^2 e^{2|\alpha_n^{(2)}|\ell} + \|G_1(\lambda_n^{(2)})\|^2 \right] \leq \frac{\widehat{M}_2}{n^2},
\end{aligned}$$

where \widehat{M}_1 and \widehat{M}_2 are independent on n . Therefore, we obtain

$$\sum_{|n| \geq N} \left\| \Psi(\lambda_n^{(1)}) - B_n^{(1)}\Psi_n \right\|^2 + \sum_{|n| \geq N} \left\| \Psi(\lambda_n^{(2)}) - \frac{B_n^{(2)}}{r\rho_2}\Phi_n \right\|^2 < \infty.$$

Since it holds that

$$A(\lambda_n^{(j)}) \neq 0, \quad \text{and} \quad A(\lambda_n^{(j)}) \rightarrow 1, \quad (\text{as } n \rightarrow \infty), \quad \forall j = 1, 2,$$

$$0 < \inf_{|n| > N, n \in Z} |B_n^{(j)}| \leq \sup_{|n| > N, n \in Z} |B_n^{(j)}| < \infty, \quad j = 1, 2,$$

we can assume without loss of generality that, for $|n| < N$,

$$B_n^{(1)} = 1, \quad B_n^{(2)}/(r\rho_2) = 1, \quad |n| < N,$$

then $\{B_n^{(1)}\Psi_n \mid n \in Z\} \cup \{B_n^{(2)}/r\rho_2 \Phi_n \mid n \in Z\} \cup \{F_0\}$ is also a Riesz basis for \mathcal{H} . By virtue of Proposition 4.1, the generalized eigenvector system of \mathcal{A} forms a Riesz basis for \mathcal{H} . The proof is then complete. \square

Remark 4.3. We know from Theorem 2.3 and 4.2 that there is a positive integer N such that $\lambda_n^{(1)}, \lambda_n^{(2)}$ for $|n| \geq N$ are simple eigenvalues of \mathcal{A} , $\Psi(\lambda_n^{(1)})$ and $\Phi(\lambda_n^{(2)})$ are eigenvectors of \mathcal{A} associated with $\lambda_n^{(1)}$ and $\lambda_n^{(2)}$, respectively, and the sequence

$$\{\Psi(\lambda_n^{(1)}) \mid n \in Z, |n| \geq N\} \cup \{\Phi(\lambda_n^{(2)}) \mid n \in Z, |n| \geq N\}$$

is a basis sequence. So the number of the elements in set

$$\sigma_1(\mathcal{A}) = \sigma(\mathcal{A}) \setminus \{\lambda_n^{(1)}, \lambda_n^{(2)} \mid n \in Z, |n| \geq N\}$$

is less than number $4N - 1$. Although we do not know exact number of the non-simple eigenvalues of \mathcal{A} in the set $\sigma_1(\mathcal{A})$, we know that the exact dimension of subspace corresponding to $\sigma_1(\mathcal{A})$ is $4N - 1$.

Corollary 4.4 Let \mathcal{H} and \mathcal{A} be defined as before, and $T(t)$ be the C_0 semigroup generated by \mathcal{A} . Assume that $\sigma_1(\mathcal{A}) = \{\mu_1, \mu_2, \dots, \mu_k\}$. Then when $\beta - \rho_1 \neq 0$, $r\rho_2 - 1 \neq 0$, the solution of the system determined by (2.1) with initial data $F \in \mathcal{H}$ can be expressed as

$$\begin{aligned} T(t)F &= \sum_{j=1}^k \sum_{i=1}^{s_j} e^{\mu_j t} P_{s_j, i}(F, t) \Phi_{j, i} + \sum_{|n| \geq N} e^{\lambda_n^{(1)} t} \langle F, \Psi^*(\lambda_n^{(1)}) \rangle \Psi(\lambda_n^{(1)}) \\ &+ \sum_{|n| \geq N} e^{\lambda_n^{(2)} t} \langle F, \Phi^*(\lambda_n^{(2)}) \rangle \Phi(\lambda_n^{(2)}). \end{aligned}$$

\square

From Theorem 2.3 we know that the lines $\operatorname{Re} \lambda = \operatorname{Re} \frac{\tau_1}{\rho_1}$ and $\operatorname{Re} \lambda = \operatorname{Re} \frac{\tau_2}{\rho_2}$ are two asymptotes of the spectrum of \mathcal{A} . Denote

$$\omega_0 = \max \left\{ \operatorname{Re} \frac{\tau_1}{\rho_1}, \operatorname{Re} \frac{\tau_2}{\rho_2} \right\},$$

obviously, $\omega_0 < 0$. Since \mathcal{A} is dissipative operator and $\sigma(\mathcal{A}) \cap iR = \emptyset$, we can obtain the following corollary.

Corollary 4.5. Let \mathcal{H} and \mathcal{A} be defined as before. If $\beta \neq \rho_1$ and $r\rho_2 \neq 1$, then the system determined by (2.1) satisfies the spectrum determined growth assumption in the state space \mathcal{H} , i.e.,

$$\omega(T) = s(\mathcal{A}) = \max_{\lambda \in \sigma(\mathcal{A})} \{\omega_0, \operatorname{Re} \lambda\} < 0,$$

and hence the closed loop system is exponentially stable. \square
