When full-time law teaching started in Hong Kong in 1969, there were four teachers and 40 students. Today we have a staff of 50 and 600 students reading for the degree of LLB and the Postgraduate Certificate in Laws. Some 50 postgraduate students are working for coursework and research degrees.

The work of the Faculty has both local and international aspects. Our graduates are to be found in all branches of the legal and allied professions in Hong Kong and some have returned to teach in the Faculty. Our staff have published extensively on Hong Kong law and provide continuing legal education for practitioners. We have become a focus for visitors from China, the Pacific Rim and countries all over the world who contribute to our teaching and research; and our staff contribute to international scholarship through visits overseas, participation in conferences and publication in learned journals. Our students have successfully taken part in international mooted competitions which have enabled them to meet law students from many other countries.

We look forward to continuing hard work and success. We have a fine new building with first-class teaching facilities. We are reviewing our curricula to ensure that they continue to equip our students to practise law in Hong Kong's challenging environment. We are developing courses on the use of Chinese in the law. We are running a major fundraising campaign to enable us to extend and strengthen our academic work and to build the Law Library up to an international standard.

The Faculty's achievements have come about through the hard work, dedication and vision of teachers, past and present. We believe that that work has created a centre of excellence in teaching and research. The many themes within the Faculty are brought together in the Conference on the Future of the Legal System in Hong Kong to which we are delighted to welcome members of the local legal community and eminent speakers from Hong Kong and overseas.

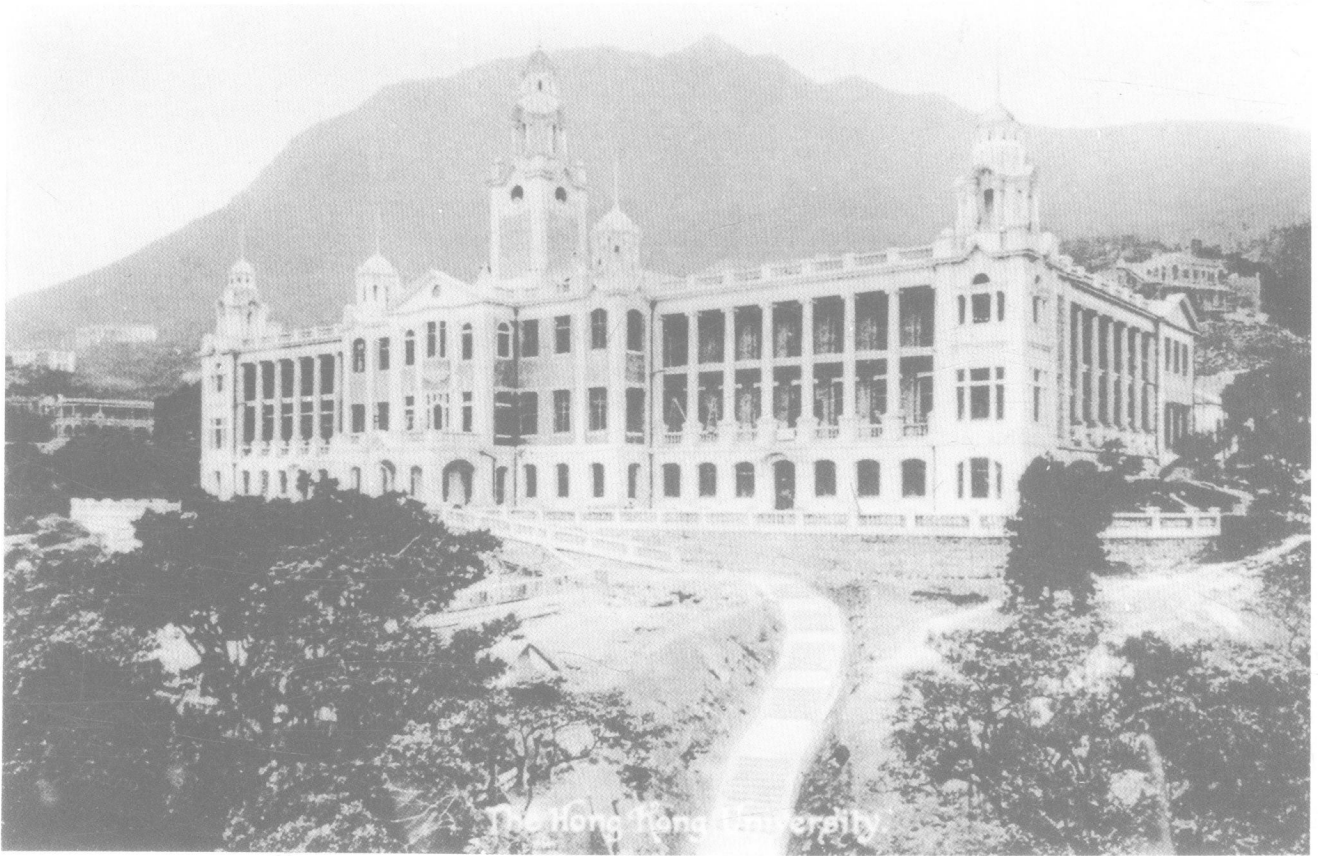

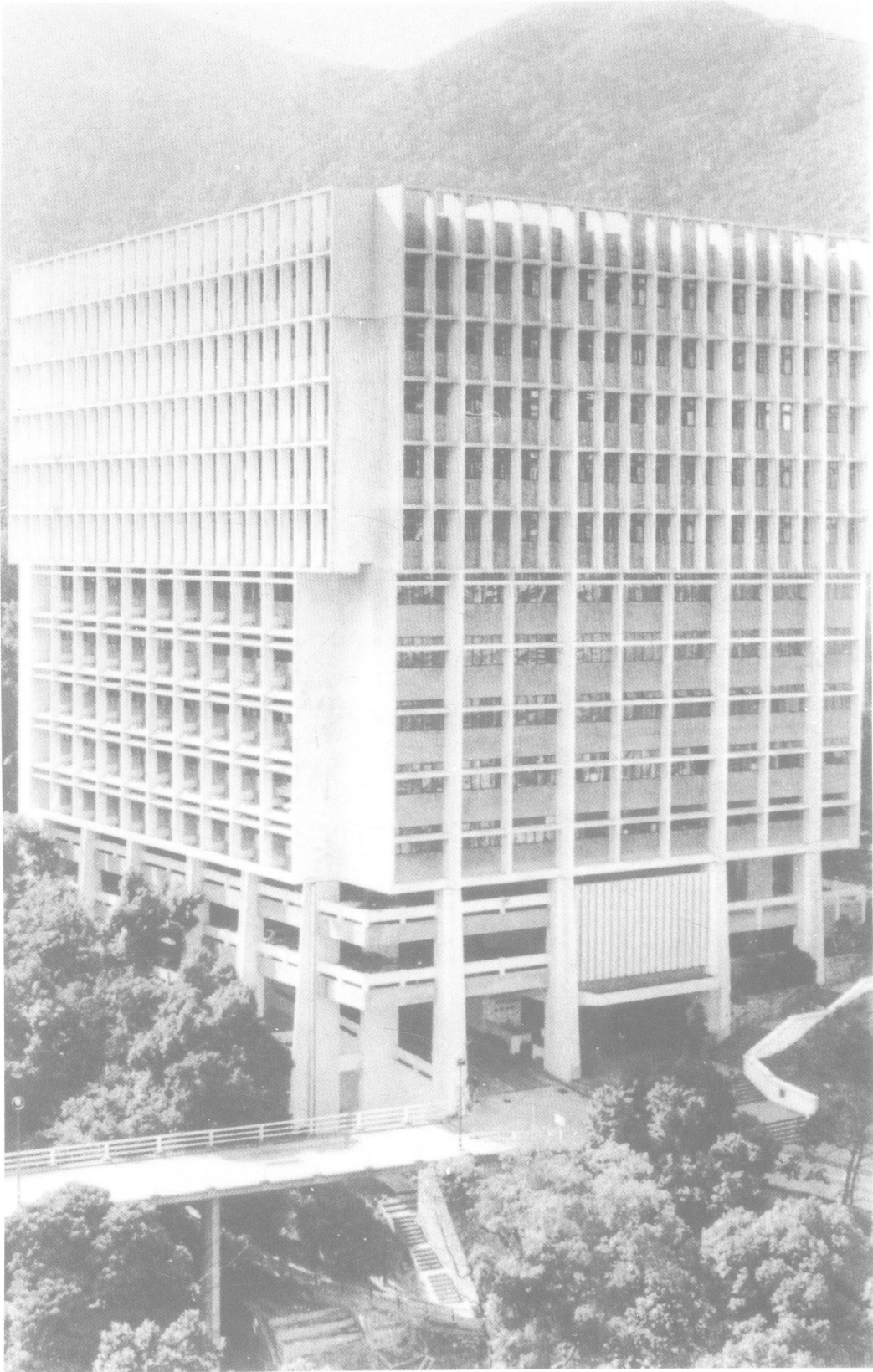

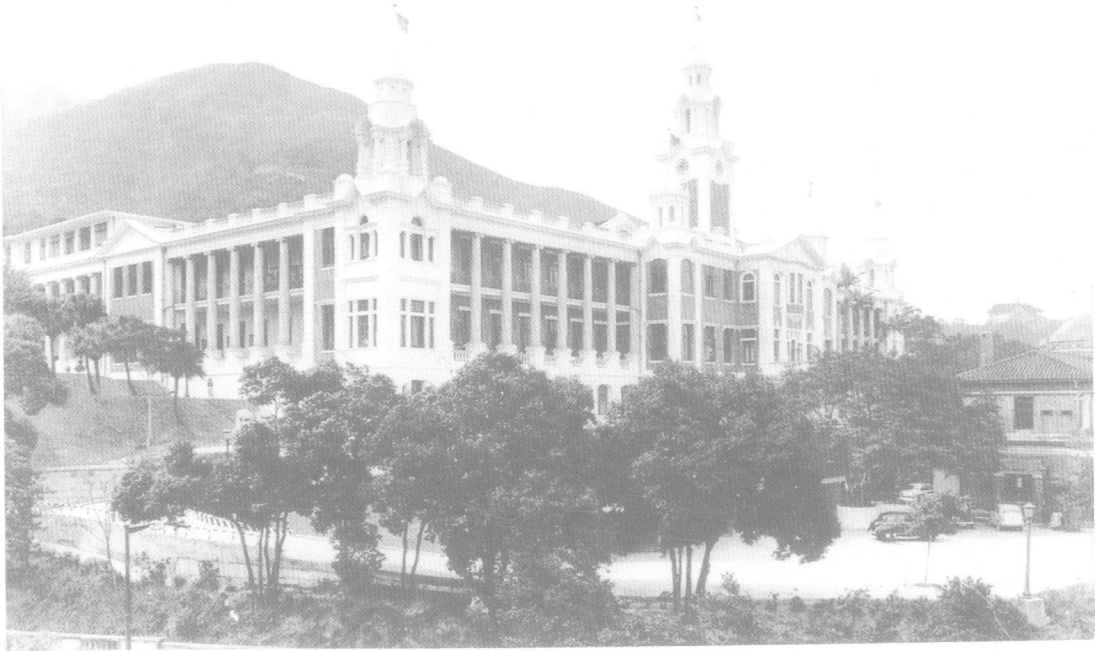

FACULTY OF LAW

The first law teacher was appointed in the University of Hong Kong in 1924 but it was only in 1962 that serious thought was given to introducing a degree in law. In 1964 the Department of Extra-Mural Studies began teaching students enrolled for the University of London external degree in law. In 1966 a working party was set up which recommended that facilities be provided in the University for the study of law leading to a professional qualification. After further advice from overseas academics, the Department of Law was established and began teaching in 1969 for the three-year full-time degree of Bachelor of Laws (LLB). Another working party then considered the professional stage of legal education in Hong Kong and in 1972 the one-year full-time Postgraduate Certificate in Laws (PCLL) was introduced.

The Department of Law was originally part of the Faculty of Social Sciences (later the Faculty of Social Sciences and Law). In 1978 Law developed into a School of Studies with its own Board of Studies. Since 1 July 1984 it has been a full Faculty comprising the Department of Law, responsible for the degrees of LLB and LLM, and the Department of Professional Legal Education, responsible for the PCLL.

In the early days the Department was modest in the number of its staff and students although not in its ambitions. It recruited a small number of young, enthusiastic and predominantly English and Welsh staff. The only one to survive this far was Dafydd Evans, the founding professor, whose departure from the University and Hong Kong in early 1990 will mark the end of an era in law education at the Faculty. Other founding staff left sooner or later and many went on to success and prominence in the legal and academic professions. Over the course of 20 years some 100 teachers have passed through the Faculty and the establishment now stands at 50. It is interesting to see the shift in the profile of the staff, from the mainly United Kingdom stock of the late 1960s, to the present mix dominated by Australasians but with an increasing number from Canada and representation also from the United States, Israel, Ireland and Sri Lanka to mention a few. The number of local teachers has been small, no doubt as a result of the rival attractions of practice, but since the early 1980s the Faculty has managed to tempt some of its own graduates to return or stay on. There are now seven local teachers and the Faculty is making strong endeavours to raise their numbers.

Initially 40 LLB students were admitted each year. With the government's constant upward reassessment of the need for lawyers in Hong Kong, the targets were steadily increased to reach 80 by the late 1970s. In 1982 the University and Polytechnic Grants Committee requested that this be almost doubled to 150 a year. This target was achieved in 1986 so that the present student population of the Faculty includes a total of 450 students in all three years of the LLB, 175 (probably to be raised to 200) for the PCLL and 27 full-time equivalent places for research and taught masters students. Some further increase in numbers may be expected, notably for higher degree students, but the recent introduction at the City Polytechnic of Hong Kong of the territory's second degree of LLB and the imminent creation there of a second PCLL have relieved the pressure on the Faculty as the sole provider of full-time legal education.

The degree of LLB curriculum was based closely on the three-year pattern common in United Kingdom universities and notably at the University of London. From the outset it took account also of Hong Kong law which, while in large part similar to English law, has its own unique characteristics. Recently the LLB has been comprehensively reviewed and plans are now in hand to modify the degree substantially to ensure that it continues to provide a liberal education in the law which meets the needs of the students, the profession and the community. The Faculty is keen that its graduates be well-versed in the technical aspects of the law but that they also have a full appreciation of the place of the law in society and develop their English and Chinese language skills to the high level of proficiency necessary in the practice of law and, indeed, the other professions and careers in which a degree in law may be of value.

The PCLL, initially designed as a fourth year for LLB graduates, quickly developed into a distinctive professional practice qualification, noteworthy for being based in a university and not under the control of the legal profession. The PCLL too has come under critical scrutiny within the Faculty in recent years with greater attention being given to the definition of its objectives and to the systematic development of training in the practical skills necessary in practice. The planning for a second PCLL at the City Polytechnic will also offer a timely opportunity for both institutions, and the professions, to review the future shape of professional legal training in Hong Kong.

In 1986 the degree of LLM was introduced. It is directed particularly, but not solely, at young graduates in practice and concentrates on the areas of international trade law, commercial law, travel law and the law of the People's Republic of China. The LLM has proved popular and has attracted several postgraduate students from overseas who provide a welcome international dimension. The majority of the LLM students are in full-time employment and come up to the Faculty for classes in the evening.

As well as its formal teaching the Faculty contributes to legal education and the legal system in Hong Kong in many ways. It provides essential editorial support and contributions for the Hong Kong Law Journal which has been the main vehicle for creating a legal literature for Hong Kong. In co-operation with the Journal, it presents the annual Law Lectures for Practitioners which are an important part of continuing legal education here. It organizes conferences and has instituted a distinguished visitors programme under which legal academics and practitioners of note can contribute to teaching and research in the Faculty.

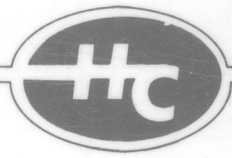

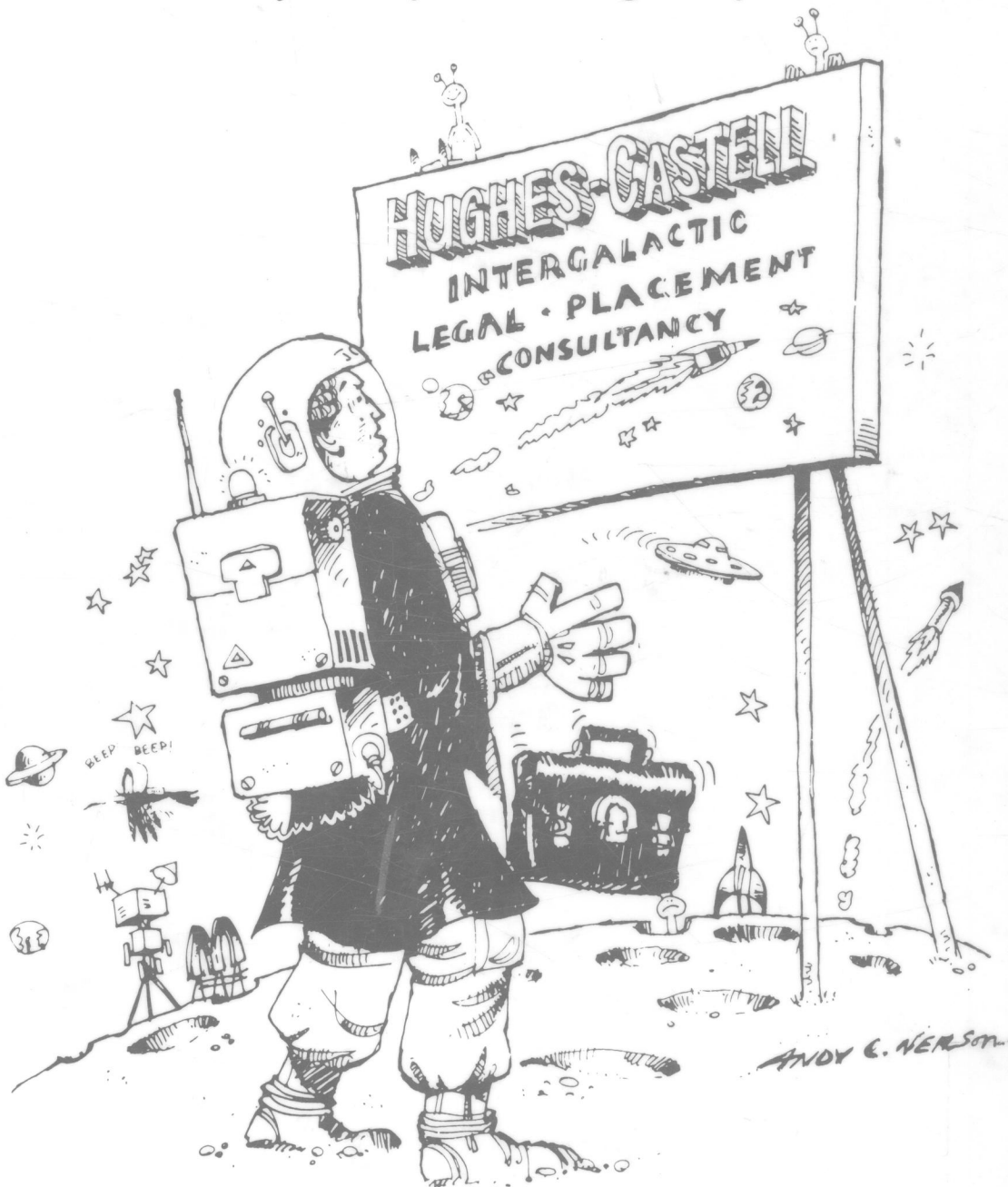
